Uses Advised Against:

When damaged or abused (e.g. mechanical damage or electrical overcharging); may burn rapidly with flare-burning effect; may ignite other batteries in close proximity.

## **6. ACCIDENTAL RELEASE MEASURES**

If the Lithium Ion Battery is subject to storage for such a long term (more than 3 months), it is recommended to recharge the Lithium Ion Battery periodically.

3 months: -10°C~+40°C, 45 to 85%RH

And recommended at 0°C~+35°C for long period storage.

The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more.

The voltage for a long time storage shall be 3.7V~4.2V range.

Do not store Lithium Ion Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects.

Keep out of reach of children.

Do not expose Lithium Ion Battery to heat or fire. Avoid storage in direct sunlight.

Do not store together with oxidizing and acidic materials.

Keep ignition sources away. Do not smoke.

Store in cool, dry and well-ventilated place.

The Lithium Ion Battery with a Watt-hour rating not exceeding 100Wh or the cell with a Watt-hour rating in not exceeding of 20Wh, The Lithium Ion Batteries according to Section II / Section IB of PACKING INSTRUCTION 965, or Section II of PACKING INSTRUCTION 966-967 of the Dangerous Goods regulation 59<sup>th</sup> Edition may be transported.
