

V、测试方法 Test Method

Tests T.1 to T.5 shall be conducted in sequence on the same cell or battery. Tests T.6 and T.8 shall be conducted using not otherwise tested cells or batteries. Test T.7 may be conducted using undamaged batteries previously used in tests T.1 to T.5 for purposes of testing on cycled batteries.

In order to quantify the mass loss, the following procedure is provided:

T.1 Altitude simulation 高度模拟

Test cells and batteries shall be stored at a pressure of 11.6kPa or less for at least six hours at ambient temperature ($20^{\circ}\text{C} \pm 5^{\circ}\text{C}$).

Cells and batteries meet this requirement if there is no leakage, no venting, no disassembly, no rupture and no fire and if the open circuit voltage of each test cell or battery after testing is not less than 90% of its voltage immediately prior to this procedure. The requirement relating to voltage is not applicable to test cells and batteries at fully discharged states.

T.2 Thermal test 温度试验

Test cells and batteries are to be stored for at least six hours at a test temperature equal to 72°C± 2°C, followed by storage for at least six hours at a test temperature equal to - 40°C± 2°C. The maximum time interval between test temperature extremes is 30 minutes. This procedure is to be repeated until 10 total cycles are complete, after which all test cells and batteries are to be stored for 24 hours at ambient temperature (20°C±5°C). For large cells and batteries the duration of exposure to the test temperature extremes should be at least 12 hours.

Cells and batteries meet this requirement if there is no leakage, no venting, no disassembly, no rupture and no fire and if the open circuit voltage of each test cell or battery after testing is not less than 90% of its voltage immediately prior to this procedure. The requirement relating to voltage is not applicable to test cells and batteries at fully discharged states.

试验电池和电池组应先在试验温度等于 72℃±2℃的条件下存放至少 6 小时,接着再在试验温度等于 -40℃±2℃的条件下存放至少 6 小时。两个极端试验温度之间的最大时间间隔为 30 分钟。此程序重复进行, 共完成 10 次,接着将所有试验电池和电池组在环境温度(20℃±5℃)下存放 24 小时。对于大型电池和电 池组,暴露于极端试验温度的时间至少应为12小时。

要求电池和电池组无渗漏、无排气、无解体、无破裂和无起火,并且每个试验电池或电池组在试验后 的开路电压不小于其在进行这一试验前电压的90%。有关电压的要求不适用于完全放电状态的试验电池和 电池组。

Vibration 振动

Cells and batteries are firmly secured to the platform of the vibration machine without distorting the cells in such a manner as to faithfully transmit the vibration. The vibration shall be a sinusoidal waveform with a logarithmic sweep between 7Hz and 200Hz and back to 7Hz traversed in 15 minutes. This cycle shall be repeated 12 times for a total of 3 hours for each of three mutually perpendicular mounting positions of the cell. One of the directions of vibration must be perpendicular to the terminal face.

The logarithmic frequency sweep shall differ for cells and batteries with a gross mass of not more than 12kg (cells and small batteries), and for batteries with a gross mass of more than 12kg (large batteries).

For cells and small batteries: from 7Hz a peak acceleration of 1gn is maintained until 18Hz is reached. The amplitude is then maintained at 0.8mm (1.6mm total excursion) and the frequency increased until a peak acceleration of 8gn occurs (approximately 50Hz). A peak acceleration of 8gn is then maintained until the frequency is increased to 200Hz.

For large batteries: from 7Hz to a peak acceleration of 1gn is maintained until 18Hz is reached. The amplitude is then maintained at 0.8mm (1.6mm total excursion) and the frequency increased until a peak acceleration of 2g_n occurs (approximately 25Hz). A peak acceleration of 2g_n is then maintained until the frequency is increased to 200Hz.

Cells and batteries meet this requirement if there is no leakage, no venting, no disassembly, no rupture and no fire during the test and after the test and if the open circuit voltage of each test cell or battery after testing in its perpendicular mounting position is not less than 90% of its voltage immediately prior to this procedure. The requirement relating to voltage is not applicable to test cells and batteries at fully discharged states.

电池和电池组紧固于振动机平台,但不得造成电池变形,并能准确可靠地传播振动。振动应是正弦波 形,对数扫描频率在7赫兹和200赫兹之间,再回到7赫兹,跨度为15分钟。这一振动过程须对三个互 相垂直的电池安装方位的每一方向重复进行12次,总共为时3小时。其中一个振动方向必须与端面垂直。

作对数式频率扫描,对总质量不足 12 千克的电池和电池组(电池和小型电池组),和对 12 千克及更 大的电池组(大型电池组)有所不同。

对电池和小型电池组:从7赫兹开始,保持1gn的最大加速度,直到频率达到18赫兹。然后将振幅保 持在 0.8 毫米 (总偏移 1.6 毫米), 并增加频率直到最大加速度达到 8g, (频率约为 50 赫兹)。将最大加速 度保持在8gn直到频率增加到200赫兹。

对大型电池组: 从 7 赫兹开始,保持 1gn 的最大加速度,直到频率达到 18 赫兹。然后将振幅保持在 0.8 毫米 (总偏移 1.6 毫米), 并增加频率直到最大加速度达到 2gn (频率约为 25 赫兹)。将最大加速度保持 在 2gn 直到频率增加到 200 赫兹。

要求电池和电池组试验中和试验后无渗漏、无排气、无解体、无破裂和无起火,并且每个试验电池或 电池组在第三个垂直安装方位上的试验后测得的开路电压不小于在进行这一试验前电压的90%。有关电压 的要求不适用于完全放电状态的试验电池和电池组。

T.4 Shock 冲击

Test cells and batteries shall be secured to the testing machine by means of a rigid mount which will support all mounting surfaces of each test battery.

Each cell shall be subjected to a half-sine shock of peak acceleration of 150g_n and pulse duration of 6 milliseconds. Alternatively, large cells may be subjected to a half-sine shock of peak acceleration of 50gn and pulse duration of 11 milliseconds.

Each battery shall be subjected to a half-sine shock of peak acceleration depending on the mass of the battery. The pulse duration shall be 6 milliseconds for small batteries and 11 milliseconds for large batteries. The formulas below are provided to calculate the appropriate minimum peak accelerations.

Each cell or battery shall be subjected to three shocks in the positive direction and to three shocks in the negative direction in each of three mutually perpendicular mounting positions of the cell or battery for a total of 18 shocks.

Cells and batteries meet this requirement if there is no leakage, no venting, no disassembly, no rupture and no fire and if the open circuit voltage of each test cell or battery after testing is not less than 90% of its voltage immediately prior to this procedure. The requirement relating to voltage is not applicable to test cells and batteries at fully discharged states.

每个电池或电池组须在三个互相垂直的安装方位的正方向经受三次冲击,接着在反方向经受三次冲 击,总共经受18次冲击。

要求电池和电池组无渗漏、无排气、无解体、无破裂和无起火,并且每个试验电池或电池组在试验后 的开路电压不小于其在进行这一试验前电压的90%。有关电压的要求不适用于完全放电状态的试验电池和 电池组。

External short circuit 外部短路

The cell or battery to be tested shall be heated for a period of time necessary to reach a homogeneous stabilized temperature of $57^{\circ}\text{C} \pm 4^{\circ}\text{C}$, measured on the external case. This period of time depends on the size and design of the cell or battery and should be assessed and documented. If this assessment is not feasible, the exposure time shall be at least 6 hours for small cells and small batteries, and 12 hours for large cells and large batteries. Then the cell or battery at $57^{\circ}\text{C} \pm 4^{\circ}\text{C}$ shall be subjected to one short circuit condition with a total

external resistance of less than 0.1 ohm. This short circuit condition is continued for at least one hour after the cell or battery external case temperature has returned to $57^{\circ}\text{C} \pm 4^{\circ}\text{C}$, or in the case of the large batteries, has decreased by half of the maximum temperature increase observed during the test and remains below that value. The short circuit and cooling down phases shall be conducted at least at ambient temperature.

Cells and batteries meet this requirement if their external temperature does not exceed 170°C and there is no disassembly, no rupture and no fire during the test and within six hours after the test.

待测试的电池或电池组应加热一段必要时间,以从外壳测量的温度达到均匀稳定的57℃±4℃的温度, 应对加热持续时间进行评估和记录;如果这种评估不可行,对于小型电池和小型电池组至少在57±4℃的 环境下存放 6 小时,对于大型电池和大型电池组至少在 57℃±4℃的环境下存放 12 小时。然后,电池或电 池组在 57℃±4℃的环境中,应接受一个外部总电阻小于 0.1 欧姆的短路条件。这一短路条件应在电池或 电池组外壳温度回到 57℃±4℃后继续至少 1 小时,或对于大型电池组其外壳温度降幅达试验中观察到最 高温升幅的二分之一,并保持低于该值。进行短路和降温阶段试验的温度至少相当于环境温度。

要求电池和电池组外壳温度不超过 170℃,并且在试验过程中及试验后 6 小时内无解体、无破裂、无 起火。

T.6 Impact 撞击

Impact (applicable to cylindrical cells not less than 18 mm in diameter)

The test sample cell or component cell is to be placed on a flat smooth surface. A 15.8 ± 0.1 mm diameter, at least 6 cm long, or the longest dimension of the cell, whichever is greater, Type 316 stainless steel bar is to be placed across the centre of the sample. A $9.1 \text{kg} \pm 0.1 \text{kg}$ mass is to be dropped from a height of $61 \pm 2.5 \text{cm}$ at the intersection of the bar and sample in a controlled manner using a near frictionless, vertical sliding track or channel with minimal drag on the falling mass. The vertical track or channel used to guide the falling mass shall be oriented 90 degrees from the horizontal supporting surface.

The test sample is to be impacted with its longitudinal axis parallel to the flat surface and perpendicular to the longitudinal axis of the 15.8 mm \pm 0.1mm diameter curved surface lying across the centre of the test sample. Each sample is to be subjected to only a single impact.

撞击 (适用于直径不小于 18 毫米的圆柱形电池)

试样电池或元件电池放在平坦光滑的表面上,一根316型不锈钢棒横放在试样中心,钢棒直径15.8毫 米±0.1毫米,长度至少6厘米,或电池最长端的尺度,取二者之长者。将一块9.1千克±0.1千克的重锤 从 61 厘米 ± 2.5 厘米高处跌落到钢棒和试样交叉处,使用一个几乎没有摩擦的、对落体重锤阻力最小的 垂直轨道或管道加以控制。垂直轨道或管道用于引导落锤沿与水平支撑表面呈 90 度落下。

接受撞击的试样,纵轴应与平坦表面平行并与横放在试样中心的直径 15.8 ±0.1 毫米弯曲表面的纵轴垂 直。每一试样只经受一次撞击。

The charge current shall be twice the manufacturer's recommended maximum continuous charge current. The minimum voltage of the test shall be as follows:

- (a) When the manufacturer's recommended charge voltage is not more than 18V, the minimum voltage of the test shall be the lesser of two times the maximum charge voltage of the battery or 22V.
- (b) When the manufacturer's recommended charge voltage is more than 18V, the minimum voltage of the test shall be 1.2 times the maximum charge voltage.

Tests are to be conducted at ambient temperature; the duration of the test shall be 24 hours.

Rechargeable batteries meet this requirement if there is no disassembly and no fire during the test and within seven days after the test.

T.8 Forced discharge 强制放电

Each cell shall be forced discharged at ambient temperature by connecting it in series with a 12V D.C. power supply at an initial current equal to the maximum discharge current specified by the manufacturer.

The specified discharge current is to be obtained by connecting a resistive load of the appropriate size and rating in series with the test cell. Each cell shall be forced discharged for a time interval (in hours) equal to its rated capacity divided by the initial test current (in ampere).

Primary or rechargeable cells meet this requirement if there is no disassembly and no fire during the test and within seven days after the test.


