




1. Lead(Pb), Cadmium(Cd), Chromium(Cr)




2. Mercury(Hg)



3. Hexavalent Chromium(Cr(VI))




4. Polybrominated Biphenyls(PBBs), Polybrominated Diphenyl Ethers (PBDEs)
